2012 Recycled Art

Juried Show

Submitting art for this juried show:

Art may be two or three dimensional. It should be made from at least 80% recycled materials, such as paper, paint, ceramic, glass, wood, metal or objects from nature. Artists are encouraged to use ecologically-friendly glues, paints, etc. for the construction of their pieces. Due to space considerations, size is limited to no larger than 3 feet at the longest side.

Submissions:

Your recycled art must be submitted to Currents Gallery ready to display. Jury fee is \$25.00 for up to three pieces and \$5.00 extra for an additional item. The limit is four pieces. Students 18 and under may submit up to three items for a \$15 entry fee. Fees are to be paid at the time of submission. All pieces must be for sale. The Gallery will retain a 50% commission on all sales. A fee refund of up to \$15 will be credited to the artist when an item sells.

Each piece must be labeled with:

- 1. Artist's name 2. Title 3. All Materials Used 4. Price

Jury:

Currents Gallery member artists will jury the show on Thursday, April 12, 2012. Awards will be given for 1st, 2nd, and 3rd place. Winners will be chosen based on overall appeal, quality of workmanship and innovative use of recycled materials. The public will vote for a People's Choice Award prior to and during the Opening Reception on Saturday, April 21.

Schedule: Submission: Friday the April 6 - Wednesday April 11 at the gallery from 10 am to 5 pm (Gallery is closed on Sunday)

Notification: By phone or email on or before Friday, April 13.

Pick up: Work NOT accepted must be picked up no later than Monday, April 17, 2012, 10 am to 5 pm.

Work accepted and displayed, but not sold, must be picked up between Tuesday, May 15 and Friday, May 18, 2012,

Exhibit opens: April 18, 2012

Reception: Saturday, April 21, from 4:00 – 8:00 pm

Exhibit closes: May 14, 2012
